#### **General Terms and Conditions**

Wein-Lagerlogistik operates exclusively in accordance with the General Austrian Forwarders' Conditions (AÖSp) and international CMR regulations.

#### Storage:

- 1. Only pallets with homogenous contents are stored. If different wines are delivered on a single pallet, they will be separated and sorted into homogeneous pallets at an hourly rate of €35.00 per person.
- 2. For storage without a delivery note, an additional administrative fee of €5.00 will be charged.
- 3. Outbound orders submitted after 10 a.m. will be dispatched on the next working day.

# Transport:

- 1. Transport orders must be submitted by fax or email by 2 p.m. the day before pickup.
- 2. Goods brought to Wein-Lagerlogistik GmbH by the winemaker must be delivered by 11 a.m. to ensure same-day dispatch.
- 3. Parcel shipments are sent exclusively in certified boxes.
- 4. Deliveries are made as consolidated freight unless the client requests special transport. Deliveries are made on weekdays, excluding Saturdays, within Austria behind the first lockable door. <u>All information is provided without guarantee.</u>
- 5. If the recipient refuses to accept a delivery, Wein-Lagerlogistik is entitled to a reasonable fee for the return transport. If Wein-Lagerlogistik incurs additional costs due to delayed acceptance, these shall also be borne by the client.
- 6. Additional services, such as removal, will be charged at an hourly rate of €30.00 subject to prior agreement.
- 7. Island transports in Germany are subject to an island surcharge according to the daily rate.
- 8. For scheduled deliveries, the following additional surcharges shall apply:
  - a. Delivery by 9 a.m.: +55%
  - b. Delivery by 12 p.m.: +35%
  - c. Delivery by 4 p.m.: +20%
- 9. Notification by telephone is possible upon previous request for a fee of €7.50.
- 10. Private shipments are only possible if the telephone number of the recipient is provided.
- 11.A fuel surcharge will be applied as indicated until further notice.

#### *Invoicing:*

- 1. Invoicing takes place weekly for transport and monthly for storage.
- 2. Payment terms: Immediate payment upon receipt of the invoice without any deductions.

- 1. Any damage must be noted on the delivery slip (receipt) and immediately reported in writing to Wein-Lagerlogistik. Any concealed damage must be reported within 7 days from the delivery date.
- 2. The invoice for damages without tax must be issued immediately to Wein-Lagerlogistik.
- 3. The return costs for damaged packages must be listed in the damage calculation, otherwise these costs cannot be covered by the insurance.
- 4. The damage amount will be paid out by Wein-Lagerlogistik after the insurance claim has been settled.
- 5. All return costs for goods without apparent damage shall be borne by the client.

### Liability:

- 1. Wein-Lagerlogistik is liable in accordance with Section 51 AÖSp (or internationally according to CMR) based on fault.
- 2. Wein-Lagerlogistik is not liable for consequential damages and subsequent costs such as purely economic losses, loss of profits, lost earnings or lost revenue.
- 3. Liability is not assumed if parcel services use any other box besides the certified boxes provided by Wein-Lagerlogistik.
- 4. Liability according to CMR is approximately €10.00 per kg. Additional insurance is possible depending on the value according to the SVS table upon express request.
